## McKay Re-enrollment for 2011-12

Starting May 2, participating private schools may register and enroll new McKay students and re-enroll current McKay students for the 2011-12 school year. Your school **must be compliant** for the upcoming school year in order to enroll scholarship students. Please also note:

- If a scholarship student is not returning next year, or if the student is graduating, please withdraw the student from your McKay Student List.
- If a high school student (grades 9-12) will be repeating a grade, documentation verifying or supporting that decision must be provided to our office.
- Be careful to enter the correct parent Social Security Number (SSN) when registering new students and re-enrolling current students. It is imperative that the correct parent SSN is associated with each student record; SSN discrepancies may cause a delay in payment.
- Be aware that students who are "registered only" are not considered enrolled, and will not receive payment. Enrollment includes submitting an individual student fee schedule and entering a first date of attendance.
- Enrollment must be completed by **August 2**, **2011**, in order for a student to receive a first quarter scholarship payment on September 1st.

#### **General Fee Schedule Submission**

Please remember that a general fee schedule must be submitted **prior** to enrolling any McKay scholarship students. Fee schedules for the 2010-11 school year may be copied over for the 2011-12 school year and fee amounts may be updated when logged in as a private school. The fee schedule link is located at the bottom of the private school welcome page.

Private schools will be able to update general fee item amounts until August 2, 2011. However, any new fee items must be submitted to your Regional Manager to be added to your school's general fee schedule.

#### Mark Your Calendar

**April 30**—Date that a 2010-11 intent expires if unused.

**May 1**—Date by which all Compliance issues must be resolved.

**May 2**—System is open for reenrollment.

**June 1**—Date that returning McKay students not reenrolled in their current school will become available in the system.

**June 1**—Date by which requests for missing payments must be submitted.

**July 3**—Intent filing deadline to be eligible for the first 2011-12 payment on September 1.

**August 2**—Date by which new and renewing McKay students must be registered and enrolled in order to receive the September 1 payment.

**September 2**—Intent filing deadline to be eligible for the November 1 payment.

October 2—Date by which students filing by September 2 must be enrolled to receive the second quarterly payment.

#### **FTC Testing Reminder**

When private schools participating in the Florida Tax Credit (FTC) Scholarship Program send the nationally norm-referenced assessments to be scored, they should be sure to **request national percentile rankings** (not just the number correct) from the scoring company.

Once the test scores are received by the school, copies of the score sheets with the student's name, testing date, and national percentile ranking should be sent to: David Figlio, School Reporting Compliance Center, Department of Economics, University of Florida, Gainesville, FL 32611-7140.



### In the News

Certification of Immunization, Form 680—Recent enhancements to the Florida SHOTS™ provide electronic access to student's immunization data by parents and school nurses. The new e-signed Florida Certification of Immunization, Form DH 680 has eliminated the need for a specific color of paper. Therefore, Form 680 is no longer required to be on blue paper. To determine validity of student's Form DH 680, school registrars are encouraged to utilize the guidelines on pages 7 & 12 of the Florida Department of Health, Bureau of Immunization Newsletter (Spring 2011). ## **Guide to Registration and Enrollment**

In order for a scholarship student to be eligible for payment, he or she must be registered and enrolled each year in a timely manner through the School Choice Web site (<a href="www.floridaschoolchoice.org">www.floridaschoolchoice.org</a>). This function is available for the upcoming school year beginning May 2.

#### **Web Site Tools**

To work with enrollment of McKay Scholarship students, go to the **McKay Student List** when logged in as a private school.

There you will find links to perform the following functions:

- Register New Students—for students entering the scholarship program for the first time. This function searches the database of students who have filed an intent to participate in the McKay Scholarship for the upcoming 2011-12 school year. You may search for a student by entering just a few letters of the student's first and last name, or you may narrow your search by entering any combination of the student's name, date of birth, or public school district.
- Transfer Students from Other Participating

Schools—This function allows a participating private school to transfer a McKay Scholarship student from another participating private school. Transferring students only Registers them in the new school.

"To enroll registered students, click on the student's name and select the Enroll tab."

They are not enrolled until a fee schedule and first date of attendance are entered to complete the enrollment.

#### Types of Students

The McKay Student List displays each type of student associated with your school. The definition of each type of student follows.

 Last Year Students—This is a list of McKay Scholarship students who were enrolled in your school at the end of the 2010-11 school year. You may choose to Re-Enroll a student on this list for the 2011-12 school



year, or **Withdraw** a student who is not returning. Re-enrollment includes confirming the student's grade level and parent contact information and entering an individual student fee schedule and a first date of attendance.

- Enrolled—Any student on this list has an individual student fee schedule and a first date of attendance entered for the 2011-12 school year. Only enrolled students with an eligible matrix code may receive a scholarship payment.
- Registered—Any student on this list is new to the scholarship program or has been transferred from another school. Because they are not yet enrolled, they are not eligible for payment. To enroll registered students, click on the student's name and select the Enroll tab.
- Withdrawn—Any student on this list was enrolled in your school for the 2010-11 school year and later withdrawn. A student cannot be withdrawn prior to his or her first date of attendance, and withdrawn students cannot be re-enrolled by the same private school.

#### **Handling Transfers**

A scholarship student may transfer to another participating private school at any time. During the school year, a student must be withdrawn from the old private school before he or she can be transferred to a new school. However, over the summer months (June 1-August 2), any scholarship student enrolled during the 2010-11 school year who has not already been **Re-enrolled** is available in the system to be transferred, registered and enrolled by a new private school. The new private school will be required to complete the withdrawal as part of the transfer process. This will allow students to transfer smoothly to a new school in the event that the previous school is closed or cannot be reached during the summer months.





- The deadlines for filing a parental intent and private school enrollment are statutory deadlines.
   Therefore, the Department cannot make exceptions if these deadlines are missed.
