## Florida's Charter Schools News

#### Charter School of Excellence



The Charter School of Excellence, located at 1217 SE 3<sup>rd</sup> Avenue in Ft. Lauderdale was just awarded the New Leaders for New Schools' Effective Practice Incentive Community (EPIC) Program Grant / Gold-gain award from the National Charter School Consortium for dramatically improving students' academic performance.

Recognized for its high student achievement gains on the Florida achievement tests between the 2006-2007 and 2007-2008

between the 2006-2007 and 2007-2008 school years, the Charter School of Excellence – a K-5<sup>th</sup> grade public charter school – was among the 21 highest ranked charter schools of the 144 schools in the EPIC National Charter School Consortium and **the only elementary school in the nation to receive the Gold-EPIC award.** Educators at the school will receive financial rewards of \$4,000 in exchange for working with New Leaders for New Schools to document and share the practices that led to the award-winning gains.

EPIC is unique in that the program compares charter school achievement gains across states and financially rewards educators for sharing their effective practices. EPIC is in its second year of a five-year grant funded primarily by the federal government. Schools have the opportunity to win in multiple years. EPIC awards are based on the progress students make over time, rather than overall proficiency rates. In this way, EPIC identifies and rewards schools that have had a clear impact on their students' learning. The Charter School of Excellence, an "A" school, is one of the top ten performing public schools in the state. It currently serves more than *300* students in its downtown Ft. Lauderdale campus. In August 2008, a second K-5<sup>th</sup> grade campus opened in the Davie / Pembroke Pines area.

### Staff Spotlight: Grants Management — Unit C

The Office of Grants Management serves the educational community by managing the distribution of grant funding. Its mission is to serve all valued customers, both external and internal, by assisting them in the processes and procedures for accessing funds to educate students throughout the State. To that end, staff participates in the process for pre-approval program funding allocations, and the receipt and processing of applications. Staff provides intake, data entry, budget approval, generation of Project Award Notices and dissemination of the documents to the appropriate destinations. The section supports eleven bureaus and offices and the comptrollers office. An average of 4,500 applications are accepted and processed by our team of 15 full-time staff and one (1) OPS staff. The Office of Independent Education and Parental Choice, Charter section is supported by Unit C — which includes a director and a team of three who work diligently to fund Florida's charter schools.



**Wanda Akisanya** began her career in state employment with the Florida Commission on Ethics. Over the past twenty-five years, she has worked for Florida State University, Florida Department of Financial Services, Florida Department of Highway Safety and Motor Vehicles and Florida A&M University. The majority of these years were spent working as a Personnel Specialist in Human Resources with employees explaining benefits.
