Lake Wales Charter to present at national conference

The Lake Wales Charter Schools system will make a national presentation about its very innovative Kindergarten Support Program.

Superintendent **Jesse Jackson** and other LWCS leaders received the invitation March 8, 2010 to make the presentation during the 2010 National Charter Schools Conference in Chicago this summer.



"We are excited to share our story about Kindergarten Support," said Jackson. "This is a powerful instructional program that can be replicated in other charter schools around the country."

The presentation is entitled "One Two Buckle My Shoe: Kindergarten Support Program closes at-risk gap with targeted instruction." LWCS presenters will be Jackson; Hillcrest Elementary Assistant Principal **Debbie Hunt**, who helps coordinate the K Support Program; Hillcrest K Support teacher **Lynda Norton**; and **Gary Loar**, accountability coordinator.

All four elementary schools in the LWCS system have a privately funded Kindergarten Support Program that provides additional staff and intensive, targeted instruction for students.

The LWCS system is waiting to hear if another conference proposal will be accepted. Hillcrest Elementary submitted information about its community outreach effort, Project Learn Learn Learn. The presentation is entitled "Closing the Gap: Here is Our Map" and details how Hillcrest reaches out into the surrounding community with educational resources for families, particularly hands-on materials and books for young children.

"On Monday, conference organizers told us that Project Learn, Learn, Learn was still being considered," said Jackson. "We are pleased to have one, and possibly two, programs that will receive national attention this year."

Governance Trainer Approval Application Due May 1

State Board Rule 6A-6.0784, Florida Administrative Code (FAC) is a revised rule to improve the process by which charter school governance training plans are approved by the Department and to ensure consistency with Section 1002.33(9)(k), F. S.

The Department will conduct two review periods for applications, with deadlines for submitting applications on or before October 1 and on or before May 1. Forms for submitting training plans are posted at: http://www.floridaschoolchoice.org/

Information/Charter Schools/. A training provider seeking approval must submit the original and three (3) copies of the form, or an original and an electronic copy on a CD saved as a PDF file, to the Office of Independent Education and Parental Choice.

Each approval shall be granted for up to two years from date of approval. No earlier than six (6) months prior to the expiration of approval, a training provider may submit a request for renewal of an approved training plan by completing and submitting Form IEPC-10, Charter School Governance Training Application to Renew an Approved Training Plan.
