#### New Charter Schools Director for State of Florida



The Office of Independent Education and Parental Choice welcomes Adam Miller to its staff as the new director of charter schools. He received his Masters Degree in Education from Florida Atlantic University and has been active in the field of education for the past ten years. Much of his work has centered on students with special needs, and upon arriving in Tallahassee, he worked for the Florida Developmental Disabilities Council. Adam will begin working with Office of Independent Education and Parental Choice on September 15th.

### Upcoming Deadline for Merit Award Program (MAP)

Charter schools that wish to participate in the Merit Award Program (1012.225, F.S) must submit their plans to the Commissioner by October 1, 2008. For schools with approved plans for the 2007-2008 only, the plan submitted was a two year plan which covers school years 2007-2008 and 2008-2009. The Commissioner will review the plans and request revisions as necessary by November 15, 2008. # Class Size To Be Measured at <u>School Level</u> for the 2008-2009 School Year

Section 5 of House Bill 5083 amended Section 1003.03(2)(b), Florida Statutes, to continue the school level compliance measure for class size reduction for 2008-2009. Beginning in 2009-10, compliance will be measured at the classroom-level.

#### **Ethics in Education Act**

The Ethics in Education Act became effective on July 1, 2008. Each public school district, university lab school, charter school, private school that accepts McKay or Corporate Tax scholarship funds and the Florida School for the Deaf and Blind are required to implement the provisions of this Act.
