# **Response to Intervention Training:** *Introduction to a Multi-Tiered System of Student Supports*

Last summer, the Department coordinated training for charter school operators on the Response to Intervention (Rtl) model that included general information, rationale, and benefits of implementation. In an effort to continue educating charter school operators about this effective evidence-based process for supporting students with academic and behavioral needs, we have scheduled an **Rtl pre-conference workshop** as part of the 2011 Charter School Conference.

The pre-conference workshop will provide an introduction to a Multitiered System of Student Supports (MTSS). MTSS describes the integration of Rtl for academics and behavior. The workshop will provide an overview of MTSS and ways to support one school-based problemsolving team that plans for, monitors, and evaluates implementation of multi-tiered services to address both academic and behavior needs among students. The workshop will discuss what core curriculum supports should be in place for all students, supplemental supports for some students, and intensive supports for a few students. Participants will also learn about resources available through districts to support the development and implementation of this multi-tiered system of support in their schools.

The workshop will take place on **Monday, November 14, from 1pm-4pm**. There is no charge for participation. The Dunedin Rotary Club is awarding the school \$500, on Oct. 4, that they will in turn use to buy an animal(s) for hungry people in villages and countries to be chosen later by the student council. Academie Da Vinci students finished 500 reading hours in 11 days, according to the Rotary Club.

BRADENTON -- A Manatee County charter school has been recognized as an "exemplary" site for student instruction by the Institute for School Innovation in Tallahassee. Imagine School North Manatee Campus was recognized as an exemplary CHILD visitation site -- Changing How Instruction for Learning is Delivered. Only one CHILD visitation site was recognized in Florida.

Under the CHILD methods, children stay with a core teacher for at least three years instead of going to various teachers for different subjects, Imagine Principal Jennifer Lucas said. Teachers at the elementary-school levels have specialty areas., and they use collaborative, hands-on projects in cooperation with lectures. *More...* 

### Scott turns attention to parent-driven charter schools

Florida Governor Rick Scott is looking at changing the rules for converting public schools into charters. Lynn Hatter reports the governor is floating the idea in a draft report of his 2012 legislative priorities.

Florida law allows 51-percent of teachers in a failing public school to vote on whether they want that school converted into a charter. Scott is looking to enact a Parent-Trigger, which would give the same authority to parents. The idea was supported last session by Michelle Rhee, the controversial former chancellor of the Washington, D.C. school system and education advisor to Scott. *More...*

One in every 17 Florida students attends a charter school and enrollment has tripled over the past decade. Independently managed but publicly funded, charter schools are a key alternative for parents or students unhappy with their neighborhood district public school. I released a <u>statement</u> today to let people know of the FCAT 2.0 standard setting process currently underway in Florida. In it I highlighted the fact that committees of teachers, superintendents and business leaders have spent numerous hours over the past several weeks providing feedback on how Florida should report Achievement Levels for our students' performance on statewide assessments. They offered their feedback; now we are looking for yours.

You have the opportunity to provide your thoughts on what each grade level's test scores for expected achievement should be as we continue our work together to improve educational outcomes for all students. To participate in this rule development process, please visit our webpage at <a href="https://app1.fldoe.org/rules/default.aspx">https://app1.fldoe.org/rules/default.aspx</a>. Once the feedback period concludes, our next step is to present a recommended rule to the Florida State Board of Education in December for their approval.

Establishment of these new Achievement Level cut scores is essential in our work to raise expectations for our students and adequately prepare them for the jobs of today. We look forward to hearing from you!

## **Green Ribbon Schools Initiative**



The nation's Blue Ribbon Schools award program now has an environmentally-friendly counterpart. **The Green Ribbon Schools Initiative**, according to Secretary of Education Arne Duncan, will encourage schools and communities to commit to healthier, more sustainable facilities and to provide environmental awareness education to their students. Developed jointly with the

Environmental Protection Agency and the White House Council for Environmental Quality, the program identifies and praises schools for reducing the environmental impact of schools, building a healthy environment for staff and students, and having an education component that supports those goals.

According to the U.S. Department of Education, a broad range of stakeholders have been consulted to create a program that:

- Implements energy conservation measures that pave the way for reduced environmental impact, cost savings and job creation;
- Undertakes environmental and behavioral changes in schools that ensure the health, wellness and productivity of students, teachers, and staff; and
- Promotes environmental education that supports students' strong civic skills, environmental stewardship and workforce preparedness.

# **Shining Stars**

### Three Lake Wales High graduates earn national Early Childhood Certification

Three 2011 graduates of Lake Wales High School have earned national Child Development Associate (CDA) certification for early childhood educators.

Chelsea Herman, Tasha Medlock and Anna Rodriguez were students in the LWHS Early Childhood & Teacher Education Career Academy.

"It is a wonderful accomplishment for these students! We are the only school in Polk County with students earning this certification. The CDA is a highly recognized national certification for early childhood educators," said Lisa Davis, the academy director.

"These students have 480 hours working with young children. They have passing scores on six DCF (Department of Children and Families) certification exams. They submitted six written competency statements, sat through a personal one-on-one interview with a council representative, and passed the CDA Exam," said Davis.

This year, nearly 170 students are enrolled in the LWHS Early Childhood and Teacher Education Career Academy. They take classes while assisting in the operation of the Little Highlander Academy, an

on-site preschool for infants and children to age five.

The Little Highlander Academy uses a developmentally appropriate curriculum in a hands-on learning environment. As part of their own course work, LWHS students intern with the preschool's professional staff of experienced teachers who hold CDA credentials, director's licenses and/or bachelor degrees in Family and Consumer Science.
