NACSA - Award for Excellence

Congratulations to the **Polk County** Public Schools - Office of Magnet, Choice and Charter Schools for receiving the Award for Excellence in Improving Practice presented by the National Association of Charter School Authorizers (NACSA). The Polk County Public Schools - Office of Magnet, Choice and Charter Schools oversees 26 charter schools. but their impact on Florida's authorizing environment has been much broader. In an effort to ensure continuous improvement in Polk County's chartering processes, the staff recognized the need to improve its renewal decision-making practices and documents. The challenges faced in developing a transparent and rigorous renewal process were echoed by many of the school districts in the Florida Association of Charter School Authorizers (FACSA). Since Carolyn Bridges, Senior Director of Magnet, Choice and Charter Schools at Polk County

Schools, also serves as President of FACSA, she decided to expand Polk County's project to benefit as many authorizers as possible. quently, Polk County wrote a Federal Voluntary Public School Choice (VPSC) grant which included nine Central Florida Coalition districts to work on this renewal document during the 08-09 school year. This VPSC project includes Polk, Osceola, Hillsborough, Indian River, Lake, Manatee, Orange, Pasco, and Sumter Counties.

The Florida Department of Education's Office of School Choice, recognizing the quality of work completed through this process, is using the renewal template as the proposed language for State Board Rule 6A-6.0786 "Model Forms for Charter School Applicants and Sponsors."


Parental Choice in November as Educational Policy Director for the Charter Schools Program, will work in the area of Differentiated Accountability. Muire's B.S. (Virginia Tech), M.S. and Ph.D. (Florida State) degrees are in Secondary Science Education. He served 10 years with Reynolds Aluminum, has five years of teaching experience in middle and high schools, four years with the Florida Department of Education/National Science Foundation Statewide Systemic Initiative, and ten years as a professor of teacher education at FSU, Berry College and Valdosta State University.

Muire's research has largely focused on the needs of K-12 public school teachers, recently publishing a monograph of formal educational studies entitled Some Solid Ground in Our Shifting Schools (2009). Over his career, Muire has published numerous articles, presented at professional conferences, edited government reports/textbooks, and has directed, co-developed and evaluated many private, state and federal grant projects in the areas of science, technology, engineering and mathematics (STEM) education for pre- and in-service teachers.

Using Data to Support Instruction

A guide from the Department's Institute of Education Sciences suggests how student achievement data can be used to support instruction for students.

Using Student Achievement Data to Support Instructional Decision Making recommends ways to use the data to do such things as: adapting lessons or assignments to students' needs, altering classroom goals or objectives, or modifying student-grouping arrangements.



This practice guide recommends five ways to use student data effectively: (1) make data part of an ongoing cycle to improve instruction; (2) teach students to examine their own data and set learning goals; (3) establish a clear vision for school-wide data use; (4) provide supports that foster a data-driven culture within the school; and (5) develop and maintain a district-wide data system. Each recommendation describes action steps for implementation, as well as suggestions for tackling obstacles that may impede progress.
