Title I Funds for New Charter Schools

The Charter School Office would like to remind you that eligible charter schools are entitled to receive Title I funds within five months of opening or significantly expanding enrollment. If you are a first year charter school, and you believe that you are eligible for Title I funds (based on your percentage of students eligible for Free and Reduced Lunch), you should contact your school district to discuss the eligibility threshold.

The Elementary and Secondary Education Act (ESEA), as amended by No Child Left Behind in 2001, requires that Local Education Agencies (School Districts) implement procedures that ensure that each charter school opening for the first time receives the proportionate amount of Title I funds for which it is eligible within five months of the date the charter school opens. Section 1002.33, Florida Statutes, includes the same provisions.

The federal regulations also include a general prohibition against School Districts relying on enrollment or eligibility data from a prior year in determining a charter school's eligibility to receive Title I funds during an academic year in which the charter school opens for the first time, even if allocations to other public schools are based on a prior year's data. In other words, your current year's enrollment data must be used to determine Title I eligibility.

Parental Involvement Representative

One of the changes that was made during the 2011 Legislative Session was to require that all charter school governing boards appoint a representative to facilitate parental involvement and to post the contact information of that representative on the school's website. The statutory language is provided below.

Section 1002.33(7)(d)1., Florida Statutes: Each charter school's governing board must appoint a representative to facilitate parental involvement, provide access to information, assist parents and others with questions and concerns, and resolve disputes. The representative must reside in the school district in which the charter school is located and may be a governing board member, charter school employee, or individual contracted to represent the governing board. If the governing board oversees multiple charter schools in the same school district, the governing board must appoint a separate individual representative for each charter school in the district. The representative's contact information must be provided annually in writing to parents and posted prominently on the charter school's website if a website is maintained by the school. The sponsor may not require that governing board members reside in the school district in which the charter school is located if the charter school complies with this paragraph.

Professional Development Statewide Online Tobacco Prevention and Intervention Teacher Training Project

In the continued effort to reduce and prevent tobacco use among school-aged children, the Florida Department of Education (DOE) is working in partnership with the School District of Palm Beach County to provide a statewide online tobacco prevention education course.

This distance learning course is a professional development opportunity for all public school K12 teachers and guidance staff. Registration is ongoing through May 11, 2012. There is no cost to personnel who participate in the online course, and they will have 24-hour access seven days a week to complete the course. Participants receive effective teaching strategies and integrated approaches to delivering tobacco prevention education in science, social studies, language arts, mathematics, health, and physical education.

This is the second year the course has been provided statewide. Based upon the evaluation of the first year's results, teachers increased their knowledge, and the students increased their knowledge about tobacco and changed their attitudes and behavior regarding tobacco use. SIGSBEE NETS HALF-MILLION-DOLLAR MILITARY GRANT

Sigsbee Charter School, which serves mostly children whose parents work at Naval Air Station Key West, has received a \$540,000 federal grant. The hefty grant arrives at the K-6 school one year after it left the Monroe County School District's supervision and was transformed into a charter school by locals, both civilian and Navy, who tore out the drywall, painted classrooms and stripped floors to reopen the school building at the Sigsbee Park Annex.

Sigsbee Principal Elisa Jannes said the \$540,000 will allow the school to develop a "cutting edge" Science, Technology, Engineering and Math (STEM) program over the next three years. The program is designed to help military-connected students who face academic obstacles due to multiple moves due to deployment. *Read more....*

THE BROAD FOUNDATION ANNOUNCES NEW AWARD FOR URBAN CHARTER SCHOOLS

The Eli and Edythe Broad Foundation today announced a new annual award, the Broad Prize for Public Charter Schools, that will be bestowed to the charter management organization demonstrating the best academic outcomes for black and Latino students and those coming from low-income families. The winner of the 2012 prize will be announced at the June 2012 National Charter Schools Conference in Minneapolis, hosted annually by the National Alliance for Public Charter Schools, the nationwide advocacy organization for the charter school sector. To be eligible, charter management organizations must have five or more public charter schools in operation and 1,500 students enrolled as of the 2007-2008 school year; at least 40 percent of students eligible for free or reduced-price school lunches since 2008-09; 40 percent or more students from minority groups since 2008-09 and 75 percent of its schools located in urban areas. Twenty organizations meet the criteria, including KIPP, YES Prep and Green Dot Public Schools. After the winner is announced, a team of experienced researchers and practitioners will conduct a site visit to identify

practices that supported student achievement performance. These best practices will be released shortly thereafter. *Read more...*

REPORT DOCUMENTS CHARTER SCHOOL GROWTH

Six school districts across the country now have at least 30 percent of their public school students enrolled in charter schools — with Washington D.C. at No. 2 on the list. And 18 systems have more than 20 percent of their students attending charters, according to a new re-port. The charter demographics report, released by the National Alliance for Public Charter Schools, lists Los Angeles as topping the list (see below) of districts with the highest number of charter school students — 79,385 (which was 12,576 more this school year than last). If those students were in a single school system, it would be in the top 45 of the largest U.S. school districts. Read more......

PRO-CHARTER SCHOOL LOBBYING GROUP EMERGES

A new lobbying group for charter schools officially launched on Monday. With support from the Walton Family Foundation, the Florida Charter School Alliance will advocate for policies that benefit charter schools. The formation of this group is further evidence of the increasing political potency of charters and the divisions between them and traditional public schools.

Funding Opportunities

Whole Kids Foundation School Garden Grants - The School Garden Grant Program is the joint effort of Whole Kids Foundation, Whole Foods Market and FoodCorps. The Whole Kids Foundation is able to provide grants of \$2,000 to support school garden projects in the United States, United Kingdom and Canada. Eligibility: applicants must be a 501(c)(3) nonprofit organization or nonprofit K-12 school that is developing or currently maintaining a school garden project that will help children engage with fresh fruits and vegetables. Maximum award: \$2,000. Deadline: December 31, 2011

Microsoft: DigiGirlz High Tech Camp - Microsoft DigiGirlz High Tech Camp for girls works to dispel stereotypes of the high-tech industry. During the camp session, girls listen to executive speakers, participate in technology tours and demonstrations, network, and learn through hands-on experience in workshops. This year camps will take place at various dates throughout the summer in Stonybrook, NY; Charlotte, NC; Fargo, ND; Redmond, WA; Las Colinas, TX; and St. Louis, MO. Maximum award: free attendance to camp. Eligibility: girls grades 9-11 in the 2010-2011 school year and at least age 13 at time of application, with the exception of the Fargo, ND and Las Colinas, TX locations, where eligibility is restricted to grades 7-10 and 8-11, respectively. Deadline: Varies by location

Ben & Jerry's Foundation: National Grassroots Grant Program - Through the National Grassroots Grant Program, Ben & Jerry's Foundation grant program aims to further social justice, protect the environment and support sustainable food systems. Grants of up to \$15,000 are provided to grassroots, constituent-led organizations that are using community organizing strategies to accomplish their goals as well as organizations that provide technical support and/or resources to such groups. **Deadline: Rolling**

Earthwatch Education Fellowships - The Earthwatch Institute offers educators fully funded fellowships for hands-on learning with leading scientists doing field research and conservation on one of 130 projects. Earthwatch's Education Fellowships are national in scope, and supported by a wide range of businesses, foundations, and individuals. Maximum award: full cost of expedition, including all research costs, meals, housing, on-site travel, etc. Eligibility: K-12 classroom educators of any subject(s) from public or private schools nationwide.

Deadline: Rolling basis throughout the spring.

Brown Rudnick Charitable Foundation Grants - The Brown Rudnick Charitable Foundation Corporation's Limited GEO: Grants to Help Inner-City Educators fund specific, one-time future education-related needs or ideas that promise to improve inner city education within one year of the grant award in one of the cities eligible for foundation grants. Maximum award: \$2,000. Eligibility: small, concrete projects that will improve inner-city education in Boston, Hartford, Providence, New York or Washington, D.C. within the coming year. **Deadline: None**

Campbell's Labels for Education - The Labels for Education Program gives schools free educational equipment in exchange for labels from Campbell products. Maximum award: varies. Eligibility: Schools or parents coordinate label drives to raise resources for schools. **Deadline: None**
