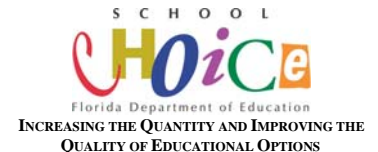

## MEMORANDUM

**SUBJECT:** Request for Proposals (RFP) for the Interdistrict Agreements for Expanding School Choice through Voluntary Public School Choice (VPSC) Models

---

The Florida Department of Education announces the Request for Proposals for the Interdistrict Agreements for Expanding School Choice through Voluntary Public School Choice (VPSC) Models. The Voluntary Public School Choice (VPSC) program aims to strengthen the availability, accessibility, and equity of educational options for parents to secure a high quality education for their children. The purpose of the program, with particular emphasis at the secondary level, is to implement interdistrict and/or multi-interdistrict agreement models among partnering school districts to create and/or enhance existing transfer agreements thereby increasing public school choice options by expanding access to K-12 school choice programs. Partnership agreements should substantially impact students in lower-performing schools. Approximately \$5,100,000 is projected to be available within the five-year VPSC program period to support the development and implementation of the interdistrict agreement models. Initial funding during the first budget period of the five-year VPSC program will consist of \$743,500. A minimum of \$100,000 to a maximum of \$170,000 is expected to be awarded for each approved interdistrict and/or multi-interdistrict agreement model during the first budget period.

Request for Proposals training sessions will be held to provide further explanation of the application process. Details related to the agenda and schedule will be posted by March 17, 2008, at the IEPC website. Frequently asked questions will be posted by April 7, 2008, at the IEPC website. Questions will not be answered by telephone or e-mail. **Questions and answers will not be addressed after April 4, 2008.**

Completed proposals are due in the Office of Grants Management no later than the close of business on April 14, 2008.
