Prior Year in Attendance

Florida law requires a student to have spent the prior school year in attendance at a Florida public school in order to be eligible for a McKay Scholarship. "Prior school year in attendance" is defined by section 1002.39(2)(a)1., Florida Statutes, as being reported for funding in the preceding October and February Florida Education Finance Program surveys.

Therefore, any intent filed during the 2009-10 school year will be verified by the Department against the **October 2008 and February 2009** FTE survey data. A student **does not** have to be reported for funding in the October 2009 funding survey to be eligible for the current school year.

There may be instances when a student misses the current-year October survey count; however, the student's eligibility is determined based on the prior school year's FTE surveys and the student's present status as a public school student with an IEP.

It is the school district's responsibility to ensure the student has an IEP and to enter the appropriate matrix number within 30 days. If you have any questions, please contact your Regional Manager.

DJJ and McKay Eligibility

When determining **initial McKay eligibility** for a student, please be aware that a student is not eligible while he or she is enrolled in a school operating for the purpose of providing educational services to youth in Department of Juvenile Justice (DJJ) commitment programs. However, time spent in a DJJ commitment program counts towards a student's prior year in attendance if the program is funded under the Florida Education Finance Program.

A current McKay Scholarship student who becomes enrolled in a DJJ commitment program for 15 or more calendar days is no longer eligible for the McKay Scholarship. This is considered a "Return to Public School" and should be indicated as such in the Eligibility Change section of the student's General Information page (accessed by logging on to the School Choice Web site). If the student spends less than 15 consecutive days in the DJJ commitment program, the student remains eligible to continue in the McKay program.

District FTE File

The McKay Scholarship District FTE File will be available **November 20, 2009.** This file provides each district with a list of students participating in the McKay Scholarship Program that received a payment. These students must be reported as McKay students (3518) to generate the necessary funding unless the student is physically in attendance at a public school. In this case, the student must be reported as a public school student.

McKay Prepayment Verification File



Prior to each quarterly McKay payment, a prepayment verification file is posted for the districts to download and verify a McKay student's enrollment or withdrawal from the public school district.

The Student ID contained in this report is the same Student ID that was assigned by the district when the student filed the intent to participate. If the district has a current Student ID that does not match the one assigned in the McKay prepayment verification file, it can be updated by simply e-mailing Payment Specialist Scott Lingo at scott.lingo@fldoe.org.

The e-mail should contain the student name, Student ID assigned in the McKay prepayment verification file and the new Student ID the district would like assigned.

Services to Students with Disabilities Placed in Residential Care Facilities – The 2009 Legislature passed Senate Bill (SB) 1128 to create a new section of law related to the provision of educational services to exceptional education students with disabilities placed in private residential facilities. District Verification File: McKay pre-payment file which is exported to districts to verify students are not enrolled in public school system. This file contains all students the DOE *intends* on paying.

District FTE File: McKay post-payment file which identifies the students **who were** paid for the specified payment period and who will need to be reported to generate FTE funding.
