## **District Verification Deadlines**

District enrollment verification of students to be funded through the McKay Scholarship is an important accountability safeguard built into the program to ensure funding is appropriately distributed. The chart below displays the verification dates for the 2010-2011 school year. For each payment period, the McKay student file

will be available to districts via the Northwest Regional Data Center (NWRDC) site on the date listed for district review and verification, and must be submitted by the deadline in red. Once payments have been issued, the NWRDC will post the list of paid students.

District Verification File: McKay pre-payment file which is exported to districts to verify that students are not enrolled in the public school system. This file contains all students the DOE intends on paying.

District FTE File: McKay post-payment file which identifies the students who were paid for the specified payment period and who will need to be reported to generate FTE funding.

# **HB 1505 Scholarship Application**

House Bill 1505, related to Education Programs for Children with Disabilities, took effect July 1, 2010. Parents may submit a **House Bill 1505 Scholarship Application** for the McKay Scholarship via the School Choice Web site. When the form is submitted, the Department of Education will automatically verify whether the child:

- Was enrolled and reported by a Florida public school district for funding, during October and February Florida Education Finance Program surveys, in any year between July 1, 2005, and June 30, 2010.
- Would be a first-time McKay Scholarship recipient in the 2011-2012 school year.

When the HB 1505 Application is submitted, the district can view it on the Web site via the Quick Nav Bar. When the parent receives a confirmation number, they are instructed to contact their current school district as soon as possible. The school district ESE office will determine whether the child is an eligible student with a disability and will develop a current Individual Education Plan (IEP) if one is needed. IEPs must be completed by June 30, 2011.

### **Take Note**

### **Beware of District Virtual School**

McKay parents and private schools are able to enroll McKay students in up to two Florida Virtual School (FLVS) classes per year while maintaining their McKay Scholarship. FLVS is not funded through FEFP, and thus does not result in loss of the scholarship.

However, enrolling in a **district-run** virtual school program which is FEFP-funded **will result in for-feiture** of the scholarship. If your district offers such a program, please ensure that registrars are aware of this issue and screen for private school students who may be enrolled in the McKay Scholarship Program.

# **Enrollment Verification Tips**

### **Enrollment Status**

Because the August Enrollment Verification process concludes before school begins, there may be uncertainty in some cases as to the student's enrollment status. As a policy, if a student has not officially withdrawn from public school, or has registered as a new public school student, then the district should indicate the student as *enrolled* on the Enrollment Verification Form.

However, if the student was withdrawn from public school by the parent, or if the student was not enrolled in public school at the end of the previous year, the student should not be shown as enrolled as a public school student for the current year.

### Withdrawal: A Critical Step

When a student is determined to have returned to public school, the district *must withdraw* the student on the Web site to indicate the student returned to public school, in addition to reporting the public school enrollment date. Withdrawal will prevent the system from incorrectly generating any further payments. (Simply reporting the enrolled date will cause the current payment to be cancelled, but future payments may still be processed if the student is not also shown as withdrawn from McKay.)

Note: If a student does withdraw from the district to attend a McKay private school after being withdrawn via the McKay Web site, a Matrix Correction Form will be required to get the student's matrix updated and validate the withdrawal.

### DJJ

In accordance with statute, a McKay Scholarship student is considered returned to public school upon entry into a Department of Juvenile Justice (DJJ) detention center for a period of fifteen days. School districts should track McKay students that have entered a DJJ facility and on the fifteenth day, withdraw the student from the McKay program via the McKay Web site. These students should be withdrawn as "Student in DJJ" and the withdraw date should be the first day the student entered the DJJ facility when the fifteen days were accrued.


