McKay District Verification Deadlines

District enrollment verification of students to be funded through the McKay Scholarship is an important accountability safeguard built into the program to ensure funding is appropriately distributed. The chart below displays the verification dates for the 2017-18 school year. For each payment period, the McKay Verification File will be available to districts via the Northwest Regional Data Center (NWRDC) site on the date listed for district review and verification, and must be submitted by the deadline in red. Once payments have been issued, the NWRDC will post the list of paid students.

Gardiner Scholarship Program

The Gardiner Scholarship Program has been available to students since 2014 and currently has 8,160 students participating. The program is administered by Scholarship Funding Organizations. Eligible students receive funds from their Scholarship Funding Organization deposited into a personal account. Unlike McKay, students are not required to attend a public school prior to participating in Gardiner. Participating families may be enrolled in private schools or home education programs and use the funds for private school tuition, therapies, services, etc.

When logged into our website a Gardiner student list is available in the left menu. This list contains all students residing in your district whose eligibility has been confirmed by a Scholarship Funding Organization. These students may not yet have been funded. If a family requests a matrix review prior to or after being funded, use this list to report the new matrix.
