# **Compliance Renewal**60 Days to Resolve Outstanding Issues

**March 1st is the deadline** for submission of the Compliance Form. Your form must be postmarked by the deadline to be eligible to participate in the Scholarships Program for the 2011-2012 school year.



Following the timely submission of the Scholarship Compliance Form, **renewing schools must resolve any outstanding compliance issues**, including the submission of inspection reports and fiscal soundness documentation (if applicable), **on or before May 1, 2011.** 

Schools unable to resolve compliance issues by May 1st <u>will not be eligible</u> to participate in the scholarship programs for the 2011-2012 school year.

Upon demonstration of compliance for the 2011-12 school year, the Department will send the private school a letter confirming compliance.

If you have any questions related to your school's compliance status, please contact your regional manager.

### McKay Payment Discrepancies

The third quarter McKay Scholarship payments for the 2010-11 school year were recently distributed. It is very important for participating private schools to review these payments immediately, as well as other payment records from throughout the school year. Any discrepancies must be submitted to the Office of Independent Education and Parental Choice by March 4, 2011, for corrections to be reflected in the final payment of the school year that is scheduled for April 1. Any further payment correction requests for the current school year must be submitted to the Department no later than June 1, 2011 in order to receive payment.


#### **Private School Employee Fingerprinting**

As private schools continue to resolve compliance related issues, it is important for both renewing schools and new participants to know and understand the employee fingerprinting requirements. **Every employee or contracted personnel with direct student contact must <u>electronically</u> submit a set of fingerprints through the Florida Department of Law Enforcement (FDLE) for a state and national background screening. The screening results must be securely stored at** 

the school's location and be available for inspection by the Department of Education should your school be randomly selected for a site visit.

Please note that Department of Children and Families (DCF) background checks <u>do not</u> meet the statutory screening requirements for participation in the state scholarship programs because DCF does not provide the results to the private school for screening against <u>s. 435.04, F.S.</u>. Only teachers with a valid Florida teaching certificate are exempt from this requirement according to <u>s. 1002.421(2)(i), F.S.</u>

## **FTC Testing Reminder**



As a reminder, private schools participating in the Florida Tax Credit (FTC) Scholarship Program must **annually** administer or make provisions for FTC students in grades 3-10 to take one of the nationally norm-referenced tests identified by the Depart-

Once the test is administered and the scores are received by the school, copies of the scores must be reported to the Project Director, Professor David Figlio. When sending the assessments to be scored, please be sure to **request national percentile rankings** (not just the number correct) from the scoring company. As in previous years, Professor Figlio will be collecting copies of each FTC student's test scores for the 2010-11 school year. Send copies of score sheets with the student's name, testing date, and national percentile ranking to: David Figlio, School Reporting Compliance Center, Department of Economics, University of Florida, Gainesville, FL 32611-7140.

#### **Mark Your Calendar**

**March 2**—Date by which students filing by January 31 must be enrolled to receive the April 1 payment.



**March 3-16**—Attendance Verification period for the April 1 payment.

**March 1**— Date by which Scholarship Compliance Form must be postmarked, after being submitted online, printed, signed and notarized.

**April 30**—Date on which a 2010-11 intent expires if unused.

**May 1**—Date by which all Compliance issues must be resolved.

**June 1**—Date by which requests for missing payments must be submitted.

**July 3**—Intent filing deadline to be eligible for the first 2011-12 payment on September 1.

**August 2**—Date by which new and renewing McKay students must be registered and enrolled in order to receive the September 1 payment.

**September 2**—Intent filing deadline to be eligible for the November 1 payment.

# FROM JUST READ, FLORIDA: WHY TEXT COMPLEXITY MATTERS



When teaching reading and engaging students in text reading, it is important to match students' ability with the text they are reading. Using complex text in English/language arts, science, social studies, technical subjects, and content reading, supported by comprehension strategies like read-alouds,

deep discussion, multiple opportunities to model text understanding through written responses, and scaffolded thinking aligned to complex questions, will accelerate text understanding.

with an emphasis on counseling, Scott worked with the United Way in New Orleans and later in management.





- The deadlines for filing a parental intent and private school enrollment are statutory deadlines. Therefore, the Department cannot make exceptions if these deadlines are missed.
