## **Private School Annual Survey**

The new Private School Annual Survey for the 2009-2010 school year will be available September 1, 2009 on the School Choice Web site at <u>www.floridaschoolchoice.org</u>. Completing the Annual Survey is one of the requirements outlined in Section 1002.42, Florida Statutes, which states in part:

"Each private school shall annually execute and file a database survey form on a date designated by the Department of Education."

We encourage you to complete the Annual Survey as soon as possible and take advantage of benefits such as:

- Being listed in the Directory of Private Schools, where parents can access and view your school's information;
- Serving as the first step in applying to participate in the McKay and Corporate Tax Credit Scholarship Programs;
- Receiving timely updates on federal initiatives or changes affecting private schools;
- Allowing eligible students in your school to qualify for a Bright Future's Scholarship; and
- Receiving information from the Florida Department of Education on issues or requirements affecting private schools including IDEA, Title I, attendance requirements, records retention, and student immunizations.

Please note that there have been changes in the Annual Survey. The changes are in the "Student Information" and "Graduate Information" sections. The "Race and Ethnicity" section under "Student Information" has been updated to reflect recent changes in the federal reporting guidelines. Additionally, the "Student Information" and "Graduate Information" sections should only reflect information and numbers for students residing in Florida.

# Private School Closure

When a private school closes, or has no students, it is required to transfer all permanent student records to the superintendent of the public school district in which it was located. If a member of a private school system or association, the school may transfer records to the principal office of the system or association. The school should then notify the Department of Education of the date of transfer of student records, the location of storage, the custodian of such records, and the number of records to be stored. The department acts as a clearinghouse and maintains a registry of transfers of student records.

It is not the intent of the Legislature to limit or restrict the use or possession of any student records while a school is operational, but to facilitate access to academic records by former students seeking to continue their education or training after a private school has become defunct. (Section 1002.42, F.S.)

# Preparing for the Flu

Please be advised about the new guidance for our nation's public and private schools: "Preparing for the Flu - Communication Toolkit for Schools (Grades K-12)" released by the CDC on August 7, 2009. You can find it online at: <u>http://www.flu.gov/plan/school/schoolflutoolkit.pdf</u>.

Secretaries Kathleen Sebelius (HHS), Duncan (DOE) and Napolitano (DHS) along with Thomas Frieden (Director, CDC) hosted a press briefing to announce the updated school guidance for the Fall 2009 influenza season. Key strategies include: 1) keep sick kids and staff home, 2) the importance of washing hands and 3) the importance of covering a cough. Two major changes from the Spring 2009 guidance include: 1) the period of exclusion should be 24 hours after the fever is gone and 2) school closures need to be a local decision. The guidance also includes considerations should the virus become more virulent. They stressed 1) the importance of remaining flexible because this continues to be an evolving situation and 2) vaccine is the strongest defense.

# 2009-2010 School Entry Requirements

Prior to entry, attendance, or transfer to Florida schools (kindergarten through 12th grade), each child shall have on file a Florida Certification of Immunization, DH 680, documenting the following:

### Public/Non-Public Schools Kindergarten through 12th Grade:

Four or five doses of diphtheria-tetanus-pertussis (DTaP) vaccine

Two or three doses of hepatitis B (hep B) vaccine

Three or four doses of polio vaccine

Two doses of measles-mumps-rubella (MMR) vaccine

Two doses of varicella vaccine\* for kindergarten and grade one

One dose of varicella vaccine\* for grades two through eight

\*Varicella vaccine is not required if there is a history of varicella disease documented by the healthcare provider.

### Additional Seventh Grade Requirement:

In addition to compliance with all other required immunizations, children entering, attending, or transferring to the seventh grade in Florida schools must complete the following:

# Providing Services to Eligible Private School Children

**Summary**: Local Educational Agencies (LEAs) that receive Title I, Part A, funds must ensure that private school students receive equitable services. This document describes the funding process, services that LEAs must provide, the process LEAs must follow, and the documentation LEAs must keep.

# **Supplemental Educational Services (SES)**

SES is a part of the No Child Left Behind (NCLB) Act. SES providers offer high-quality, research-based instruction designed to increase academic achievement for eligible students who are enrolled in Title I schools that have not made Adequate Yearly Progress for three consecutive years in reading or math.

Eligible students are public school students from low income families, as determined by the school district for the purpose of allocating funds under Title I. Students attending private schools are not eligible to receive funding for SES.

Private schools are eligible to be SES providers. Private schools that are approved as providers of SES may only receive funding for supplemental educational services provided to public school students.

### Florida Bright Futures Scholarship Program

The Office of Student Financial Assistance (OSFA) will provide the Bright Futures 2009-10 initial eligibility brochure in downloadable format (which may be printed) on our Web site this year. (We will not be printing Bright Futures 2009-10 initial eligibility brochures and the brochures will not be included in Florida Trend's NEXT magazine.) We remain committed to providing you, students, and parents with Bright Futures Scholarship Program information and found some creative ways to provide this information.

### **Bright Futures Security**

In order for private school students to earn a Florida Bright Futures Scholarship, your high school must be registered as a private high school with the Florida Department of Education and request, from OSFA, secured access to the Bright Futures Scholarship Program's Evaluation System to submit your high school students' transcripts online for evaluation for a Florida Bright Futures Scholarship. ### New FASTER Capability for Private High School Transcript Submission

We now have a process that allows private schools to send transcript data to Bright Futures via spreadsheet templates which can be converted by the FDOE to FASTER files. Private school library media specialists will need to send an email from their school email account and include: school name, county name and media specialist name to the <u>SSYRA volunteer webmaster</u> at myssyra@gmail.com to get a pdf of the letter.

If after the first two weeks of the new school year, you have not received the letter via email from either your district media contact, or FAME, contact the <u>SSYRA volunteer webmaster</u> at myssyra@gmail.com. Include your name, school name, district, and please send the email from your school email account. Make sure that email from <u>myssyra@gmail.com</u> is not blocked so you can receive the response.

## "Grow Healthy" School Garden Project

Did you know that many schools in Florida are using gardens as a tool for hands-on, student-centered learning? Research has shown that children who participated in garden based nutrition interventions led to an increase in their servings of fruit and vegetables. Teachers perceive school gardens to be an effective way of enhancing the academic performance, physical activity level, and healthful eating habits of their students.

In partnership with the Florida Department of Education's Food and Nutrition Management, Office of Healthy Schools, and the Florida Department of Health's Comprehensive Cancer Control Program, 32 schools have been selected to participate in the "Grow Healthy" School Garden Project. Each garden kit contains:

- A supply of green beans, lettuce, basil, radish, tomato, and carrots seeds (approximately 200 seed packets)
- > A supply of sunscreen SPF 15
- > One-page fact sheet with helpful websites
- Gardening Angels How-to-Manual
- Plate Full of Color, a 36-page children's book, the third in The Eagle Book Series, developed by the Centers for Disease Control (CDC) and the Indian Health Service
- Plate Full of Color Classroom Activities (Pre-K 4<sup>th</sup> Grade)
- Nutrition-related brochures

Each school that receives a school garden kit has been asked to send a brief narrative and picture of the harvest by December 31, 2009. Pictures and narratives will be featured on the Florida Department of Education's web site.
