Short-term Sub-grant RFP Released

The Request for Proposal (RFP) for the 2012-13 Short-term Intensive (STI) Dissemination Sub-grants competition has been released. To obtain the RFP and all necessary forms to submit a full application for the STI competition, please go to:

Essentially, the 2012-13 STI program is prepared to make approximately 15 grant awards to eligible charter schools in Florida that have not previously received a CSP dissemination sub-grant. Each dissemination grant will be between \$100,000 - \$200,000 that must be budgeted over a 12 month project period.

According to federal Charter Schools Program (CSP) guidelines, a charter school may use dissemination grant funds to assist other public schools, including public charter schools, in adapting the charter school's program (or certain aspects of the charter school's program), or to disseminate information about the charter school through activities such as:

- developing curriculum materials, assessments, and other instructional supports that promote increased student achievement and are based on successful practices within the assisting charter school; and
- conducting evaluations and developing materials that document the successful practices of the assisting charter school and that are designed to improve student performance in other public schools.

The Department's priorities require short-term interventions that are focused on delivering research-based models in one of the following two categories:

PRIORITY #1 – Improving Early Childhood Literacy (Grades K-5)

Providing teachers and leaders in public schools, including public charter schools, with academic resources and professional support for developing lesson plans, curriculum materials, assessments, and implementing instructional approaches that promote early childhood literacy (reading, writing and language arts) for students in grades K-5. Project activities and deliverables must be based on scientifically-based research and the successful practices occurring within the assisting

charter school. Evidence of success with promoting early childhood literacy must accompany the application along with a detailed explanation of how the products (lesson plans, curriculum materials, assessments, and instructional approaches) will be disseminated and employed.

PRIORITY #2 – Increasing Parental Involvement in Grades K-12

Providing staff development, programmatic resources and strategic support to classroom teachers, leaders and other key stakeholders in public schools, including public charter schools, to increase the involvement of parents in the education of their children (students in grades K-12). Project activities may include assisting charter schools with identifying, developing and/or implementing a variety of parental involvement opportunities, with a special emphasis on providing meaningful participatory opportunities for parents of K-12 students considered at-risk of academic failure, including exceptional education students. Evidence of success with increasing parental involvement at the assisting charter school must accompany the application along with a detailed explanation of how the successful parental involvement program(s) will be disseminated and employed.

Outstanding Teachers Needed for RttT Assessment Bank

The Florida Department of Education (FDOE) has awarded a Race to the Top contract to Pearson for the Florida Interim Assessment Item Bank and Test Platform development.

Pearson, in collaboration with the FDOE, is seeking outstanding Florida teachers (grades K through 12), 300 writers and 75 reviewers, to write and review selected response, short response, constructed response, extended response, and essay response items as well as performance tasks in English / Language Arts, Mathematics, Science, Social Studies, and Spanish.

As you are aware, Florida has adopted the Common Core State Standards (CCSS) in English Language Arts and Mathematics to guide instruction and increase student achievement; ELA and Mathematics items will be developed to the CCSS. This includes CCSS literacy standards for Science and Social Studies. Items for Spanish, Social Studies, and Science will be developed to Florida's Next Generation Sunshine State Standards. The expertise of Florida teachers will be a key component in the creation of this online item bank that will support high-quality instruction and student achievement. To this end, we are requesting your recommendations for talented educators in your district to participate in this project.

For item writers, the time commitment for teachers selected will include 3-4 hours of WebEx training, followed by personal time to complete the writing of assigned item sets. Participants will be paid to attend the training (\$15 per hour, maximum of \$60) and will also be paid \$20.00 for each submitted item. Pearson will execute a consultant agreement

with the teachers selected for this opportunity.

For item reviewers, the time commitment for teachers selected will include 1-2 hours of WebEx training organized by content area, followed by personal time to complete the review of assigned item sets.

Participants will be paid to attend the training (\$15 per hour) and will also be paid \$3.00 for each reviewed item. Pearson will execute a consultant agreement with the teachers selected for this opportunity.

U.S. Department Of Education May Issue New Guidance on Charters and Special Education

George Miller, D-California, to call on the Senate to pass a charter school bill adopted last year by the House. "The bill requires charter schools to have recruitment and enrollment practices that promote inclusion, retention, and engage students with limited op-

portunities to attend charter schools," he said. Commissioner Robinson explains assessment system in letter to parents

Florida Department of Education Commissioner Gerard Robinson recently wrote to parents to explain Florida's accountability plans and allay misconceptions. Below, in full, is the text of the Commissioner's letter.

July 2012

Dear Parent/Guardian,

By now you have received your child's results on the state-required FCAT and End-of-Course assessments. These assessments serve as annual academic checkups to measure your child's progress in key subject areas and help ensure that your child is on track for college or career.

Florida also uses the results to calculate school grades. Schools that improve a letter grade or earn an A receive additional state funds – up to \$100 per student – in recognition of their academic achievement. Struggling schools can get assistance and additional funding – an average of almost \$2,000 per student for F schools – to help them improve.

As grades for elementary, middle and many combination schools become available, you may notice that some schools have lower grades than last year. That does not necessarily mean that the schools, teachers or students are not doing as well as they were before. There were a number of changes to the state's accountability system this year that impacted the results.

To help better prepare students for college and careers, the state has been moving to higher academic standards, new assessments that measure students' progress toward meeting the standards, and higher achievement levels for subjects such as reading and math. These new standards, assessments, and achievement levels are being used to determine school grades this year.

Also, Florida received a waiver from the federal government this year that allows the state to have one accountability system instead of two – one state and one federal. The waiver requires Florida to include all students – including those with disabilities and English language learners with at least one year of instruction in the U.S. – in its accountability system.

The combination of changes to Florida's accountability system will cause a temporary drop in some school grades. However, we can also expect student performance to improve as it did in 2007 when Florida made revisions to the school grading formula. At first, the number of A and B schools fell from about 2,000 to 1,952, but, in the two years that followed, A and B schools rose to 2,317.

Each time Florida's school grading system has increased expectations, student performance has improved over time, which is the primary goal of Florida's accountability system. Florida will continue to make the adjustments and investments necessary to ensure all students have the opportunity to get the knowledge and skills they need to be successful in school and beyond.

Please know that, along with the State Board of Education and your district leadership, I am working to make certain that schools and teachers have the resources they need to ensure that your child is getting the best education possible.
